PRETRIAL: INSTALLATION OF IGNITION INTERLOCK

STEP 1: Call Clerk of Court's office to see if eligible for driving privileges (440) 286-2670, option 1.

STEP 2: Once eligible, you **MUST** bring the following:

- \$25.00 for driving privileges (any modification or additional driving privilege(s) will be an additional charge of \$25.00 each).
- Current proof of insurance.
- Registration of vehicle with color, make, model and year.

STEP 3: Once you have received and paid for your driving privileges, you are now eligible to schedule an appointment to have the ignition interlock installed.

STEP 4: Call Nationwide Interlock 866.694.6099 and only speak with Catlin, Mariam or Josh to make an appointment.

POST CONVICTION: INSTALLATION OF IGNITION INTERLOCK

STEP 1: Call Probation Department to see if eligible for driving privileges 440.286.2649.

STEP 2: Once eligible, you **MUST** bring the following:

- \$25.00 for driving privileges (any modification or additional driving privilege(s) will be an additional charge of **\$25.00** each).
- Current proof of insurance.
- Registration of vehicle with color, make, model and year.

STEP 3: Once you have received and paid for your driving privileges, you are now eligible to schedule an appointment to have the ignition interlock installed.

STEP 4: Call Nationwide Interlock 866.694.6099 and only speak with Catlin, Mariam or Josh to make an appointment.

Disconnection Fee	\$50

Total \$315 and must be paid in full at the time of installation

MONTHLY SERVICE FEE: \$140.00

METHODS OF PAYMENT: Auto pay, Money Order, Bank Check, Personal checks and Credit or debit cards accepted. When customers pay by credit card there is an additional 3% surcharge.

- ❖ Additional fees may apply - please read service contract prior to installation
- ❖ Motorcycles or Tesla's will not be fitted with an Interlock Device.
- ❖ Certain GMC, GM, Jeep and other vehicles (particularly those made in 2019 and later may require extra labor to install).

REMEMBER: YOU MAY NOT DRIVE LEGALLY until you have both items (i.e. driving privileges from the Court (*not your disposition sheet or order*) and ignition interlock installed in vehicle).

Therefore, you **MUST HAVE A DESIGNATED DRIVER**, drive your vehicle AND you to the Court, Probation Department and to the Ignition Interlock service center facility.

Lastly, prior to install, you **MUST** provide proof of your driving privileges & insurance; otherwise, it will not be installed.
